The year 2020-2021 was a difficult one on account of the Covid pandemic. In Delhi and Noida we continued to attend to the poor and indigent patients, supporting them in their medical treatment. We distributed ration kits to the homeless and those in living in slums, especially domestic workers. In Alwar, we were able to keep our patients safe in Anandam Vijay Mandir and Dadhikar and distributed ration kits in large numbers to the poor and vulnerable.

During the pandemic, Sapna Shikshalaya moved to the villages. The overwhelming support offered by parents to provide space and infrastructure to run the school was laudable. We ensured that our girls did not 'unlearn.' A special pat to the principal and teachers who went to the villages to teach during the pandemic, showing extraordinary grit and commitment.

We procured equipment worth INR 42 lakhs for the Mahatma Gandhi Netralaya. We have no words to thank Escorts hospital and individuals who donated for this cause.

The BPO was largely work from home. It delivered despite an extraordinary situation. The counselling centre for women continued to function throughout the pandemic despite all odds.

Resource mobilization continues to be a challenge to match our expanding work. Our strength are individual donors who trust us. We are grateful to Give India - a fund raising platform for helping us raise more and more resources. A special word of thanks to organizations such as Power Trading Corporation, Rural Electrification Corporation, Interglobe, Bry Air/Dessicant Rotors, I-Probono, IFFCO TOKIO, and Trikal Food for supporting us.

I am thankful to our sewaks who work tirelessly day-in and day-out. I must acknowledge the commitment and contribution of Prof. Ranvir Singh, Sujata Prasad, RRP Singh, and Vikas Gupta towards the growth of the organization.

I am happy to inform that Sapna was graded NGO 3 by IRR Advisory (a rating agency) which indicates 'good operational and financial performance.' Sapna was empaneled by TISS under their CSR Hub. Nonetheless, we need to work hard on capacity building and designing standard operating procedures for our varied activities.

We relentlessly strive to be transparent and accountable and make no compromise on three fundamental principles viz. integrity, discipline and sewa.

2. To our Stake holders

The hallmark of Sapna is "Selfless Service" that we constantly endeavour to infuse in whatever we do. Building trust at all levels, total transparency, integrity and honesty in our dealings and taking care of all our stake holders – beneficiaries, donors, workers, suppliers, and the society that we serve is our commitment.

2.1 Strategic highlights

Anandams, Our Homes for Sick and Destitute at Vijay Mandir, Dadikar and Noida and their growth and development are our prime strategic intent. It is planned to construct Block C at Dadikar. Proposal for construction of the building has been submitted to Rural and Electrification Corporation for funding under Community Social Responsibility project.

Education of Children is another area that our focus lies. Considering the popularity of the Sapna Sikshalaya and rising numbers over the years, it has become imperative to have our own School building. Efforts are afoot to procure land at Dadikar for the school.

Mahatma Gandhi Netralaya has grown over the years after the new building was constructed. We are in the process of rationalizing its processes and systems and enhancing its capabilities to meet growing community needs.

We turned to solar power to meet our increasing power needs. With our commitment to environment and its greening and reducing our carbon footprints, Solar Panels are under installation and Sapna will be power surplus contributing to the grid.

2.2 Financial performance

Covid 19 Pandemic threw grave financial challenges before us with declining receipts through donations. Despite the challenges, Sapna met all its commitments with prudence and financial probity. Except for two months when a small percentage of the salary of staff had to be cut, all salaries were paid in time. Entire Sapna team came together to meet the challenges.

2.3 Operational highlights

With all the restrictions during covid pandemic, day to day operations in Anandam and Sapna Shikshalaya specially, were a challenge, that team Sapna so effectively and innovatively met. Social distancing, basic hygiene of washing hand, wearing masks were strictly put in place and implemented. The first phase of pandemic passed off without any untoward incident.

Our teachers under the leadership of the principal organized classes for the children in the villages in small groups maintaining all covid protocols because all children did not have access to online platform for continuing with their education. It was an innovative and brave program for which the team Sapna Shikshalaya needs special mention and our respect and appreciation.




Team Anandam too needs special mention for taking care of close to 100 patients effectively without any covid cases in the first phase.

Our workers at Delhi involved with Health Care Facilitation Service, reported for duty on all days and did outstanding work under trying circumstances in distributing ration to innumerable poor patients stuck during the lockdown and providing basic health care support that were required.

2.4 Looking ahead



5. Looking Back – Connecting the dots

Sapna is a dream in the making - a dream for better India with happy people striving to live a meaningful life. Poverty prevents all dreams and creates a debilitating state of survival for existence. India outlined its dreams, in very trying times, after years of servitude and struggle, in its constitution. It promised to all its citizens justice social, economic and political, equality status and opportunity, welfare of all its citizens and assured the dignity of its individuals.

To actualize those dreams, Sapna has positioned itself and has grown organically over the years taking on projects and plans that arose out of the needs of the poor. A chance visit to Safdarjung Dharmashala one evening, led to like-minded people coming together to meaningfully contribute in an organized manner. Sapna got registered at Delhi as a civil society on 21st October 2004 under Societies Registration Act (XXI) of 1860.

The services of Sapna began with weekly ration distribution at Safdarjung Hospital Dharmashala. A number of other individuals were too doing their bits in their own way. Their efforts were combined to form an organized group of SAPNA. There were a number of people who had personally suffered debilitating accidents and were struggling to remain afloat. They all became a part of dedicated SAPNA team. The services were informal and rendered in most trying circumstances from the pavements of Safderjung Dharmashala. Food, medicines, diagnostic test, OPD and various other services arising out of the need of the patients got added depending upon the resources and demands.

JPNA Trauma Centre was right across the road, where too the workers began assisting patients. First request to rehabilitate a patient came from The Trauma Centre in 2007 and SAPNA moved with fits and starts ahead. Given below is our journey

6. Meeting the challenges of Covid 19 Pandemic

Sapna's initiative during first wave of Covid-19

Operation COVID 19 Pandemic Lockdown Relief Effort: Support the poor with dry rations for a week

By March 11, 2020, when the WHO declared COVID-19 as a pandemic, its impact was being felt across the globe, by the 7.8 billion humans living on the planet. With an overwhelming majority of them in no position to help themselves. India has not evolved to a stage where those ratios—of humanity feeling the pain—can be assuaged by the State in any appreciable manner.

In an evolving crisis, when no one is able to say for sure when it will be contained and what its long-term impact could be, the stress will be placed unequally on the individual and society, and on the government—which takes the responsibility for anticipating risk and putting in the structural buffers. And the structural risk, which affects everyone, is as economic as it is biological.

The economic fallout of this unprecedented lockdown has been dire. Businesses have closed, unemployment has risen and productivity has fallen. India's growth engine was actually sputtering well before the threat of the pandemic started evolving. The shutting down of the economy has the potential now to push 400 million workers in the informal economy deeper into poverty.

Our primary focus was on feeding the hungry. In order to serve the lockdown affected migrants, daily wage earners and the very poor, SAPNA started "Operation Sapna COVID-19 Pandemic Lockdown Relief Effort" on 26th of March, 2020. The objective of the operation was to support the poor & needy lockdown affected people comprising of daily wages workers, migrants and homeless during the humanitarian crises.

With very restricted movements we made a different team of social workers for Delhi, Noida, Alwar & Bihar. We identified nearby jhuggis and needy people through our social workers and other members. They prepared a list of all such people. We tied up with local grocery stores in all three center and got packets made. Dry ration kits (Atta- 5 Kg, Rice-03 Kg, Dal- 01 Kg, Mustard Oil – 01 Litre, Sugar 1Kg. Salt- 1 Kg, Masala- 200 gm) have been provided to families suffering from acute hunger. The cost of one food kit is INR 500. We have supplied these kits to 5765 families in Delhi, Noida, Alwar & Bihar. We supported some of the families till the lockdown crisis lasts.



- **Delhi** Trauma Centre of AIIMS, Safdarjung Dharamshala, Pillangi village Sarojini Nagar, Jhuggi area near Safdarjung Dharamshala, Migrants living near Sports Injury Center, behind Trauma Center, AIIMS, Jhuggis, near Gurudwara, Naroji Nagar and slums in Vasant Kunj.
- Noida- Aghapur village, Noida Sector 41, Nithari Village & Slums Sector 31, Salalpur village in Sector 49, Harijan Basti in Sector 37 & Tigri village in Noida.
- Alwar- Village Dadikar, Dehra, Shahpur, Thekra, Todiyar, Dholidhob, Jatiyana, Hajipur, Chandoli, Kaduki, Nangli, Mangalbas, Shahpur, Alwar City
- Bihar-Motihari City- Village Rulhi, Bada Bariyarpur, Chota Bariyarpur

In addition, we are providing cooked food (both lunch and dinner) to around 50 patients of Safdarjung Hospital Dharamshala and the AIIMS Trauma Centre.

7. Public Health Care:-



7.1 Health Care Facilitation Service at Delhi Hospitals

India is undergoing an epidemiological shift in the profile of diseases, facing a triple burden of communicable diseases, noncommunicable diseases and accidents/injuries. While healthcare services are greatly skewed in favour of urban areas, the majority of the population resides in rural areas. The Indian healthcare system also operates amidst multiple supply constraints, such as facing a significant gap in human resources in terms of their availability, distribution and capacities. To elaborate, India has a ratio of 0.7 doctors and 1.5 nurses per 1,000 people compared to the WHO's ideal average of 2.5 doctors and nurses per 1,000 people. There are significant gaps even in the medical infrastructure. In 2011, in India, the World Bank reported an availability of just 0.7 hospital beds per 1,000 people. Further, India has poor public health financing - at just over 1% of the GDP being spent on healthcare. With the lowest rates of technology adoption, and just over 1% GDP being spent on the health sector, India continues to remain poor in its health outcomes.

In this dire situation, Sapna primarily facilitates poor, sick and destitute patients in receiving proper medical treatment from three major hospitals – JPNA Trauma Centre of AIIMS, Safdarjung Hospital and AIIMS. Social Service Counter at Trauma Centre is manned and managed by SAPNA. The objectives of SAPNA are: Care of and Shelter to unknown patients; Assistance to poor, sick and destitute patients in receiving proper medical treatment. Sapna aims to expand manifold its health care services in upcoming years.

In Health Care facilitation program, we arranged:

- 34 surgeries were executed by Sapna in 2020-21
- 221 diagnostic tests X Ray, CT scan, ECG, MRI etc. during covid era last year
- 56 wheelchairs, 24 Splints, 32 walkers etc.

7.1.1 JPNA Trauma Centre of AIIMS



JPNA Trauma Centre of AIIMS: At the Trauma Centre SAPNA intervenes on behalf of unknown, destitute and poor patients. We provide support to unknown/unclaimed trauma victims in the following critical areas: nursing care, pre and post-surgical needs (medicines, blood and other consumables), ambulance services, nutritional support and rehabilitation. The Trauma Centre has tasked us with managing the Social Services Counter facing the emergency. After discharge, in case a patient cannot be sent home or to a rehab center, he/she is ferried to Sapna's hospice in Alwar or Noida.

In respect to future, we tend to increase our horizon of support provided to at least 6 new patients every day.

During Pandemic, Sapna Team initiatives: -

- transported cured Covid patients to their homes in our ambulance
- helped Patients in filling Medical Forms
- distributed Dry Ration and Medical kits to patients & near by villages/Slums
- team provided Clothes, Mats, Beddings etc for people from other states

Though last year we were hit by pandemic lockdown but rigor of SAPNA team was amazing. Below are some facts from last year:-

- 126 patients been taken care in the entire year from Trauma Center
- 16 patients were sent back carefully to their hometown
- 10 destitute Patients were handed over to their families
- 32 patients were Rehabilitated in Delhi or Alwar



Story from Trauma Center-

A boy was diagnosed with Covid Positive and got admitted at Trauma Center. His father was informed and he started from Bihar (Patna) to meet his son but he expired on the way to Delhi. Then, his grandfather was contacted and came from Bihar, unfortunately his leg got fractured at the gate of Trauma Center. He was taken to AlIMS. Within few days, the same boy expired because of Covid. His Father's cremation was supported by SAPNA and son was cremated by Trauma Center, as they were not giving bodies at that time.

7.1.2 Safdarjung Hospital and Dharmashala



SAPNA evolved from a chance visit to the Safdarjung Hospital Dharmashala. It turned our attention to the destitution faced by vulnerable, uninsured poor patients faced with exorbitant medical and other expenses far beyond their means. It also turned our attention to the negative public health environment that increases health burden and made us dream of an equity oriented, people centric model of health care capable of taking care of the morbidity and mortality of people who are not able to afford even elementary health care, nutritional support and medical attention

Services provided at Safdarjung Hospital Sapna's team of trained social workers assist poor patients lodged at the Dharamshala of Safdarjung hospital. We provide food and nutrition, medicines, money for diagnostic tests, surgical and post-surgical support, Funeral Services, transportation support, rehabilitation, and a gamut of related support services.

Every year we are pushing hard to increase the scope of our help. Till now, we are taking 2-3 new patients per day, however we expect it to be raised by 5-6 new patients every day, even though its Covid suppressed environment.



Medical expenses for treatment in Safdarjung Hospital:-

Treatment in Safdarjung Hospital is free. However, patients have to bear expenses for:

- medicines not available in the hospital
- implants or replacements to be used in operations
- diagnostic tests required urgently
- ortho aid such as water beds, wheelchairs, special commode chairs, crutches
- outstation patients undergoing prolonged treatment need to arrange for food and daily provisions
- in addition, there are many unexpected expenses involved living away from home.

During Pandemic, Sapna Team Initiatives: -

- distributed Dry Ration and Medical kits to patients & Nearby villages/Slums
- team provided Clothes, Mats, Beddings etc. for people from other states
- we helped patients rejected by hospitals due to lack of space during pandemic. Provided Covid medical kits.
- transported cured Covid patients to their homes in Ambulances
- helped Patients in filling Medical Forms and in scheduling the video conferencing with doctors
- took care of patients, disowned by relatives during pandemic and took care of them in Anandam Short stay home
- Sapna bore travel expenses for sending patients back to their hometown
- creation of Known and Unknown bodies

Annual Analysis of Safdarjung Hospital: -

Though last year we were hit by Pandemic Lockdown but rigor of SAPNA team was amazing. Below are some facts from last year: -

- 385 Patients been taken care in the entire year from Trauma Center
- 9 Burnt Patients & 11 Cancer Patients taken care
- 3595 Liters of Milk donated for patients on liquid diet
- 23 dozen Banana's distributed
- 11005 Diets occurred as lunch for patients
- 8823 Diets distributed as dinner
- 2 Units of Blood were also donated



Treatment of Cancer patients with the partnership of Narayan Hridalaya

In 2019 Sapna and Narayana Hospital, Bangaluru entered into a partnership to provide relief to poor and destitute cancer patients. Nararayana Hospital under their CSR provided Rs ten lakhs to Sapna to identify the patients and get them treated at Dharmashala Narayana Hospital, Vasundhara, Delhi at concessional rates. In all 6 patients were supported under the project. The difficulty that the project faced was the cap put by Narayana Hospital at Rs one lakh per patient. Cancer treatment is very expensive. Such part support was a drop in the ocean providing temporary relief at the best.

7.1.3 All India Institute of Medical Sciences



AIIMS is an apex multi-specialty hospital in Delhi open to public. The OPD of this Hospital averages more than 2 million a year. It is well known for treatment of burns, cancer, orthopaedic complications. Patients from Bihar, UP, Haryana, Rajasthan, West Bengal even as far as Nepal and Kerala come here for treatment.

Rajgharia Vishram Sadan is a Dharamshala of AIIMS. Most of the person lodged in the Dharamshala are poor, have come from other parts of the country for treatment.

Strengthening support for poor patients seeking treatment at AIIMS Hospital. In its own modest way, SAPNA, along with other like-minded individuals and organizations, extends support to poor and indigent patients who come from far-flung areas seeking treatment at AIIMS Hospital, New Delhi, and stay in the Rajgharia Hospital Dharamshala. We, at SAPNA, have endeavored to break away from the narrow interpretation of clinical healthcare to embrace a comprehensive spectrum of needs, relevant to people living in conditions of endemic poverty, and economic insecurity. A major part of SAPNA's work centres on patients accessing treatment at the AIIMS Hospital.

In this Covid dominated environment, Sapna forecasts to increase its scope for 2-3 new patients everyday to 4-5 new patients everyday.

During Pandemic, Sapna Team Initiatives: -

- Distributed Dry Ration and Medical kits to patients & Nearby villages/Slums
- Team provided Clothes, Mats, Beddings etc. for people from other states
- We helped patients rejected by hospitals due to lack of space during pandemic. Provided Covid medical kits.
- Transported cured Covid patients to their homes in Ambulances
- Helped Patients in filling Medical Forms and in scheduling the video conferencing with doctors
- Took care of patients, disowned by relatives during pandemic and shifted them in Anandam Short stay home
- Sapna bore travel expenses for sending patients back to their hometown
- Cremation of Known & Unknown bodies

7.1.4 Support the Kidney Patients:

SAPNA has progressively expanded the regular support to kidney patients after their transplant. What began with 3-4 patients every month has grown to over 10-15 patients. NGO SAPNA has partnered with Dukhbhanjan Trust to increase the scope of their support., Chandan, Bhairav Dutt, Aman Prakash, Sonu, David, Baby Devi, Birendra Das, Buddhan Pandit, Chandan, Lallan Thakur have been receiving medicines support for many years.

SAPNA NGO provided medicine of approx. Rs 204391/- to these patient. Due to lockdown, we observed slump in demand during the year. There are between six to seven patients who are supported for a short duration with medicines till they are able to arrange their own resources or find alternative options. Sometimes support is continued keeping in view the financial condition of patients. We supported seamless dialysis of 6 patients during last year.

We would specially like to acknowledge the continued support received from Trikal Foods and Agro Pvt. Ltd for the medicine and dialysis support to poor kidney patients.

7.1.2 Our Partnership Program with other NGOs

Our partnership program with other NGOs – NGO Sapna supports other NGOs in health care programs. There are many individuals and Trusts who have the resources but not the organization to run programs. Sapna provides its infrastructure and manpower resources to operationalize their programs. The objective is to see that the suffering poor patients may reap the benefits in the process.

NGO Sapna identifies the needy patients from Safdarjung Hospital, or Trauma Centre or AIIMS, identifies their needs and connects the person with the partnership organization for support. In most cases the entire operation is carried out by SAPNA and the bills are submitted to the Trust for sanction and payment. Sapna thus acts as a via-media in the process. In some cases

the trust pays an administrative fees in cash or kind. The Trusts that Sapna supports are:

7.1.2.1 Dukh Bhanjan Trust

Is run by Mrs. Tara Kocher. She is a very kind and compassionate lady. She has been working in Safdarjung Dharmshala for more than 20 years as an individual donating her own savings. Sapna has provided an organized platform to her to tailor her offerings more rationally and judiciously. Her Trust majorly supports in surgeries in Safdarjung Hospital, Kidney problems – medicines, dialysis, diagnostic test, cremations, transportation, et al. Sapna is obliged to her and her Trust for this wonderful partnership that has stood the test of time of many years. In the pandemic her support has been singular in providing relief to many stranded migrant patients. We thank Dukh Bhanjan Trust for the great work and support provided in surgeries, diagnostic tests etc. Not only this, but providing the Wheel Chairs, Air Bed, Rations, Transport Charges, Cremations, Medicines.

Mrs. Kiran Soni Gupta - She too belongs to an industrialist family and does a whole lot of yeomen's service for years in Safdarjung Dharmashala. We are grateful to her for her association with us for a common purpose.

Sapna Family thank Kiran Ji for her relentless support in getting Surgeries done, providing medicines, Diagnostic tests along with Transport Charges for the patients.

7.1.2.2 Bakshi Chibber Trust

Mrs. Anju Chibber got associated with Sapna and its programs a few years back. In the current financial year, she donated wheel chairs, walkers, airbeds, etc for for Rs. 6.5 lakh. She also donated to Sapna Rs. 2.5 lakh. As her confidence and trust with Sapna increases, her support to is seeing upward growth.

7.2 Anandam – A home for the homeless

Anandam provides shelter to those unfortunate ones who do not have a home or have been abandoned by their families or are unknown. Some are even in a comatose state. The Home for the Homeless at Alwar (Rajasthan) acts as a feeder for such survivors at the Trauma Centre (AIIMS) and Safdarjung Hospital Dharamshala at Delhi who are in need of recuperative care and support.

We also believe that their first right is to reside with their own families if possible. Hence, our aim is to give them medical and supportive care till they are capable of being rehabilitated with their families. In this way, Sapna has been instrumental in restoring several sick and infirm persons to their families.

Anandam has three centers in Vijay Mandir & Dadikar in Alwar and in Noida, UP. From Mange Ramji, our first patient in 2007, Anandam has grown to 98 patients as on 31st March 2021.

7.2.1 At Alwar Anandam Vijay Mandir



The Anandam- Vijay Mandir was set up in 2007 to rehabilitate unidentified patients discharged from Jai Prakash Narayan Apex Trauma Centre, Delhi. Shri Jage Ramji, the first patient, has been with us since 2007. Most of the patients brought to Anandam are either severely handicapped, have lost their memory or are comatose.

It is located and housed in an old rent-free building in Vijay Mandir, Behror Road, Alwar, Rajasthan. The present section has 14 rooms with a capacity to provide care and shelter to 35 residents. This year 34 new residents were admitted in Anandam and 16 residents were restored to their family members. By the end of the year, we had 32 male residents. Six inmates were in coma.

In Anandam, residents are cared for like elders and family members. The Social Workers attend

to the daily needs which include personal hygiene, food, medication and physiotherapy. A well-equipped ambulance is available for transporting the inmates to Hospital in Alwar or to Jai Prakash Narayan Apex Trauma Centre & Safdarjung Hospital, Delhi in emergencies.

Prema reunites with her family in Azamgarh, Uttar Pradesh

The story of Prema is quite heart wrenching and unfortunate. She is a fiftyyear-old lady was living with her husband and two sons in district Azamgarh in Uttar Pradesh. She has psychiatric issues. One fine day Prema went missing from home. Missing complaint was lodged by her son in Azamgarh District. Prema wandered from home and got into a train that took her to Alwar. She was found roaming around Vijay Mandir in a deranged state when a social worker of Anandam spotted her and brought her to the center in March, 2018. She was shown to doctor and prolonged psychiatric treatment was started. It took six months for her to get normal. She started recovering her memory. One day she gave us details about her home and family members. One of our social workers named Vijay is also from



Azamgarh District. Vijay talked with village Sarpanch and other people from her village and arranged her reunion with family member. On 14th April 2020 her son and brother came to Vijay Mandir and we handed over Prema to his son. We arranged for her medicines. We continue to follow up her case, happy that she has settled into a routine life.

Rakesh reunion


Rakesh- a 50-year-old man met with an accident in Delhi and went into semi coma stage. He was admitted to Jai Prakash Narayan Apex Trauma Center of AIIMS. After discharge from the hospital, he got admitted in Anandam Vijay Mandir in August 2020. At the time he was admitted in Anandam, he was totally on bed and was not able to move. After a care of six months his condition improved remarkably. One fine day he informed his address and village name. We contacted the nearest police station and with the help of police we were able to find his family members. His brother came to Vijay Mandir and after all the formalities we handed over Rakesh to his family members on 12.02.2021.

Anandmayee- A home for the homeless women at Vijay Mandir, Alwar

In the recent past we have seen increasing number of homeless women. On 21st October 2019 a separate home for homeless women named Anandmayee was established at Vijay Mandir, Alwar. The objective was to provide a safe haven to women. The Anandmayee has three rooms and one large hall to accommodate 25 homeless women. Total 5 homeless joined the Anandmayee and by the end of year we had 24 female residents in Anandmayee.


7.2.2 At Alwar Anandam Dadikar

Construction of a 200 bedded hospice at Dadikar, Alwar began in 2015. The Block 'Ä' of Anandam, Dadikar was inaugurated on 18th November, 2017. Block A has 4 big halls with a capacity to accommodate 60 residents. Total 15 residents were shifted from Vijay Mandir and four residents were restored to their family members. By the end of the year, we had 40 male residents.

This facility houses patients who have recuperated and need no treatment yet, can't be rehabilitated elsewhere. A Coordinator along with social workers looks after the treatment and well-being of the patients.

7.2.3 In NCR – Anandam Noida – A Short Stay Home

Anandam, Noida (a short stay home) was started on 11th May, 2017 and its objective is to extend support for poor and needy patients who come for treatment to Apex Government Hospitals such in Delhi.


Depending upon the diagnosis the patients stay on an average for about a fortnight and entails recovery from a serious medical event such as an accident or multiple trauma, paralysis, orthopedic or a surgical procedure. Currently 14 patients are staying in the short stay home and getting treatment in Apex hospitals.

Total 36 new residents were admitted in the year and 8 were restored to their family members. By the end of the year, we had 15 residents.

Story of Dinesh

Dinesh was admitted to AIIMS with knife injuries. He was also diagnosed with Corona during this period. After getting a little better he was handed over to NGO Sapna by the hospital authorities. Dinesh used to drink a lot and his family members were not willing to take him back. NGO Sapna was instrumental in reuniting Dinesh with his family after a lot of persuasion.

7.3 Mahatma Gandhi Netralaya, Alwar



To address the problem of blindness and bridge the gap of lack of services in rural areas of Alwar district, NGO SAPNA started high quality eye care in 2007. Its mandate was to take eye care to the doorsteps of the people of Alwar by organizing eye camps in remote rural areas.


In 2010, NGO SAPNA set up a Vision Centre in partnership with Venu Eye Institute and Research Center at Vijay Mandir, Alwar. The Vision Centre was managed by a fulltime Vision Technician (Optometrist) who does vision testing and refraction and also dispenses glasses.

Looking to the need and demand

of eye care services in Alwar District, NGO SAPNA built the Mahatma Gandhi Netralaya at village kaduki on the outskirts of Alwar city. This charitable eye hospital is exclusively for the poor and underprivileged seeking secondary eye care services in Alwar, Rajasthan.

The Netralaya became functional on 25th of August 2017 and first cataract surgery was performed on 20th February, 2018. The Netralaya has two full time optometrist and one visiting eye surgeon. Every week on Tuesday the cataract surgeries are performed in Netralaya.

Looking at the numbers, in last year total 4839 patients were examined and 581 Cataract Surgeries were performed. 1620 patients called for follow up checkup.



During the year we were able to procure all necessary eye equipment's such as Phaco Machine, Microscope, Yag Laser, Auto Ref Keratometer, Autoclave, lensometer, Led Vision Chart, A-Scan, and OT Bed for the Netralaya.

We are grateful to Escorts Pvt. Ltd for providing financial assistance of Rs. 20 Lakhs under CSR for procurement of Eye equipment's. We are also grateful to all individual donors to supporting us for procurement of eye equipment's.

Our heartful thanks to Shri Manoj Chahchan for donating Non-Contact Tonometer, Slit Lamp, Instrument Trolley, OT Table, SICS Sets and Bipolar Catuery eye equipment's to Mahatma Gandhi Netralaya.


The Netralaya building is now connected with on grid solar panel. We are indeed grateful to PTC Foundation for installation for Solar Panels under CSR.

Case Study

Naresh - 45 years

Naresh is a poor laborer from village Kaduki, near Vijay Mandir Alwar, the Centre of NGO Sapna. His vision began to deteriorate very fast due to cataract and he almost became blind.

He turned up at Sapna Netralaya for check up. His case was diagnosed and identified for eye surgery. He was operated upon on 05.01.2020 along with others identified for the purpose in the eye camp. He was provided best quality lens and treatment.

After three days of admission and total support, he was finally discharged. His vision returned fully after sometime. He can now enjoy the beautiful sights of his surroundings and his family. Another life put on track with satisfaction.

8. Sapna Education

8.1 Sapna Shikshalaya – Our School

The current pandemic has been a very challenging time for Sapna Shikshalaya. Ensuring continuity of the teaching-learning process and delivery of educational content has been extremely challenging as, first, our teachers come from Alwar town that is around 10 kms away and, second, our students are girls from an underprivileged background from the neighbouring villages.

The main method of communication during these times has been mobile phones, internet and computers. Our students do not have access to computers at home but, due to the prevalence of mobile internet, they could arrange smartphones using which we conducted online classes and interactive sessions. Even after this arranging of smartphones, it has not been easy for many students to arrange internet data packages.

Highlights of the Year:-

- Online classes. Making videos of subject material from chapters and posting on the respective class-subject group.
- Home visit of teachers.
- Ongoing training for building teachers' self-confidence and English speaking skills. We realized that teachers lack in confidence when it comes to public speaking. A session is arranged every day where teachers speak on a topic of their choice in English, thus building their confidence as well as language skills.
- Computer Classes for teachers: Teachers are being made computer savvy. They are being taught MS-Word, Excel and Power-point so that they can incorporate these tools in their teaching processes.
- Regular discussion on teaching methodology as per subject and listing practical activities that can be done in the respective subject.
- A 3-day online workshop for teachers was conducted by Ms. Ratna Choudhary. The workshop helped teachers in learning classroom management techniques and communication skills and also helped teachers in identifying their own strengths and weaknesses.
- 8th July Founders day : Coronavirus could not stop the enthusiasm of our students and teachers from celebrating our Founder's Day even though the number of students was less. We celebrated by performing appropriate activities like planting trees near our school and also making charts and cards to celebrate the school's birthday.
- **Independence Day celebration:** Pandemic has not reduced the spirit of teachers and students . We celebrated it with fun and fare. Programme started with the hoisting of National Flag and singing of National Anthem. Students recited the poems and showed their love for their motherland. Few students gave a dance performance. Programme ended with distribution of laddoos.





- 1. Home Visit : Home visits are an important feature of Shikshalaya. Teachers visit the houses of students to know how they are coping with the pandemic and if they are facing any major issues which can be solved. Even teachers get to know the environment in which child is staying.
- 2. Village Classes : Teachers are regularly going to the villages to teach students. They set-up an open classroom where students can sit keeping in mind the recommended precautions. Some of the parents have provided us the compound of their house where teaching is done.

Gandhi Jayanti celebration:

Sapna believes in the ideologies of Mahatma Gandhi and, as educationists, we try to imbibe those values in our children. On this day teachers discuss with the children the teachings of Gandhiji and how they can inculcate his teachings in their lives. The junior kids of Sapna Shikshalaya painted the picture of Gandhi ji.


Diwali & Christmas : Before the Diwali Break children were told the importance of Diwali and do's and don'ts of Diwali celebration. They were told not to use crackers as it pollutes the environment. Teachers emphasized the use of earthen diyas. Due to pandemic and government norms we had a small celebration with the younger students on December 24 in their respective villages. Children made paintings related to Christmas.

Republic Day Celebration

The day started with wishing students Happy Republic Day in their respective WhatsApp groups. Teachers decorated the premises by making Rangoli outside the NGO premises and near Flagpole. The notice board was also decorated. Peepal baba was brought to unfurl the national flag. As children couldn't be called for Republic Day Celebration, the teachers were instructed to go on-line so that the students could also participate in unfurling of National Flag and National Anthem. After the National Anthem many students presented the poems and speech on-line. This was unique experience for children as they felt involved in Republic Day Celebration even though they were not present there physically. Sapna Ma'am spoke to the children about the importance of this day.

Special care by Sapna Shikshalaya

- Teachers have been continuously ensuring safety of their students during lockdown. Teachers were in constant touch with the parents, visited their houses, distributed ration, thermometers, sanitizer and masks to each and every household.
- NGO Sapna has come with one more initiative of telemedicine where our teachers and students are enrolled so whenever they require medical facility, they can utilize these services free of cost.
- The parents have been informed about the Ambulance services and oxygen services which are provided to people if required.

8.2 Pankhuri – Our supports in other schools

In 2010, "Pankhuri- Support the girl child" model programme was conceptualized and piloted in Vijay Mandir, Alwar. The idea was to support the education of girls from economically disadvantaged families of neighboring villages of Vijay Mandir to get quality education.

- 1. To support deprived and marginalized girl children in receiving quality education in existing good schools of Alwar
- 2. To find financial supports for each child to meet the cost of education


Program Strategy

The girls in Pankhuri program come from underprivileged families. Though, economic condition of the family is one of the important parameters for selection, girls who fail to access quality school is essential criteria for selection. The girls have been admitted in two reputed schools of Alwar adjacent to our Centre Vijay Mandir named National Academy and V.L Memorial School and are being provided all round support in their education.

Presently our program covers a total of 23 girls. Individual sponsors support their fees, food, uniform, books and transportation. A part time teacher monitors the academic progress of the girls in the school and provides evening classes at Vijay Mandir which supports the girls to complete their homework, followed by nutrition and shramdan.

Case studies

Karishma is 14 years old. She studies in class IX in National Academy. Her father's name is Mr. Ramchandra Negi and her mother's name is Mrs. Meera Negi. She has 2 more siblings, a brother and a sister. Before joining Pankhuri Programme, Karishma and her sister were studying at the Kaduki government school. Karishma joined our Pankhuri support the girl child programme in class UKG in 2010. She is a very intelligent girl and has high aspirations. She wants to become an athlete and wants to help people in her neighbourhood. She actively participates in games and won medals in kho-kho and racing. She is always ready to take responsibility. She supports younger girls of the program in their academics and other activities and is always ready to learn new things.

Prachi is 10 years old. She studies in class V in National Academy school. Her father's name is Mr. Shiv Kumar and her mother's name is Mrs. Mukesh. She is a very intelligent but shy girl and her handwriting is also very good. In the last 4 academic years, she received A1 grade in all subjects. Her ambition is to become a doctor because she wants to help people in her neighborhood. She also actively participates in sports and other extra-curricular activities. Her hobbies are swimming, cycling and drawing. She always keeps smiling. She loves her school very much.





9. Sapna Skill Development and Livelihood

9.1 Sapna IT Training Centre

Computer Literacy Center (CLC)

"E-learning at the door steps"

The rural youth have little or no exposure to e-learning leave aside the challenges of training youth in ICT skills and giving them meaningful employment opportunities. Many of them have not seen computers as schools in the rural areas provide no such learning. Any desire for e-learning means going to Alwar which may be beyond their means.

Established on June 21, 2007, at Vijay Mandir, Alwar, the Computer Literacy Centre (CLC) exposes rural children to e-learning and trains youth in ICT skills. Equipped with a modern computer lab, SAPNA has tied up with Rajasthan Knowledge Corporation Limited (RKCL) to run the RS-CIT course (Rajasthan State Certificate Course in Information Technology).

This year 114 students were enrolled – 72 boys and 42 girls for the RS–CIT Course (Rajasthan State Certificate Course in Information Technology) in the Centre.



Program Objective:

The overall objective of the project is to provide computer literacy training to the rural youth and prepare rural graduates to be "industry ready" in IT skills and hence enhance employment opportunities.

Targeted Benificaries


The main targeted beneficiaries are students of the rural areas who have completed their schooling (Secondary, Senior Secondary and Graduation) for whom training in some high tech. institutes would be beyond their means.

Curriculum includes MS Office, Basic Hardware, Troubleshooting and Internet. A total of 132 hours of learning is required which includes hands on practice and classroom lectures.

The examination is conducted by Varadhman Mahaveer Open University, Kota and Department of Information and Communication Technology, Government of Rajasthan. This certificate is a mandatory qualification for mostly government job in Rajasthan.

The Centre has a well-equipped computer lab and classroom. At least twenty-five trainees can have hands on training at any given time. The charges for the program are fixed at a comparatively lower cost. As a part of our quality commitment, we have fixed a higher percentage for attendance i.e., 95%. Students who are short of attendance are not allowed to take the exam. 102 students passed the exam. If there are sufficient numbers of girls separate batches are organized for them.

9.2 Sapna IT Consultancy (BPO)

BPO (SAPNA IT Consultancy) - "Employment at the door steps"

SAPNA runs an ambitious rural business process outsourcing program aimed at creating employment for the rural youth.

Objective:

The objective is to provide employment opportunity to youngsters who have IT skills but are hesitant to leave their villages due to family circumstances and background.

In 2020-21, 10 IT Executives and 15 Data Entry operators under a Coordinator IT were employed. To maintain the quality of our services to high standards we have also recruited people from nearby cities who have an engineering or Master background. The Rural BPO of SAPNA has previously worked with companies such as Punj Lloyd, India Post and INFOSYS. We are currently providing support to an American Pharmaceutical company. An IT consultancy platform has been set up in 2018 to take on commercial engagements.

As the demand for IT jobs is growing in the area, SAPNA's BPO would like to expand its activities.

Case Study

Mijaj is an enthusiastic 25-year young boy from the village Nandanheri in Alwar District. He belongs to a lower middle-class family of farmers and his father was only earner member. Unfortunately, after an accident he became handicapped.

He enrolled himself in Computer Literacy Center for the RS-CIT course in June 2017 and successfully passed the examination. He was looking for employment as he was struggling with his economic condition. We interviewed him and provided a job in Rural BPO Project (Sapna IT Consultancy). His life changed after joining Sapna. He became financially stable and starting contributing his share with his family. He found gainful employment nearer his home.

He enjoys working in Sapna where he admires the inclusive and happy environment of all the teammates. He finds himself lucky to be a part of Sapna family.

9.3 Jan Sewa Kendra (E-Mitra Center)

E-Mitra is an ambitious E-governance initiative of Government of Rajasthan (GoR) which is being implemented state using Public-Private Partnership (PPP) model for convenience and transparency to citizens in availing various services of the Government and Private Sectors under a single roof at their door steps using an e- platform. The services are delivered via counters known as CSC (Common Service Center).

NGO Sapna with the objective to help the villagers to get their certificates on a nominal cost started e-mitra center in Vijay Mandir in 2010. The center provides services such as Ration Card, Voter I card, Pan Card, Bhamasah Card, Labor Card, Pension form, Caste Certificate, Income Certificate, Residence Certificate, Life Certificate, Police Verification & Scholarship forms. An e-mitra operator under a supervisor looks after the complete work.



9.4 Sapna Skill Development Center – Noida

NGO Sapna started its operation in Noida in 2017 with Anandam-A short stay home. After that nutrition support to Aaganwadi Center was started. In 2019 Sapna started supporting Skill Development Center which was providing skills training to slum ladies of Nithari Village in Sector 31, Noida. NGO SAPNA team organized the poor women coming from slum into groups, provided training for awareness and understanding and working towards building, entrepreneurship and skill training. NGO SAPNA is also trying to help these groups in arranging inputs, extension and marketing, introduce savings and internal lending, help in maintenance of accounts and link them with the banks for credit requirements. NGO SAPNA is acting like a facilitator which will ensure proper training of women group members to meet the market demand of skilled workforce.



Objective

- To offer training on all industrial machines used for mass production.
- To provide, sustainable livelihood opportunities to women from underprivileged community.
- To train on various businesses related activities from procurement to marketing of finished goods.

GEOGRAPHICAL COVERAGE:

This project is being implemented first in slums close to sector 31, NOIDA, GB Nagar, Uttar Pradesh, 201301 and then upon successfully achievement of objective same will be replicated

in other slums areas in Noida

NAVYA- An initiative to empower women economically.

SAPNA has begun working with women artisans to revive the handcrafted traditions of Rajasthan. We are planning for the artisans of Bihar, Jharkhand, Madhya Pradesh and Chhattisgarh. The unlocking of the creative economy will lead to transformational changes and address seminal livelihood issues. We are enabling women in Noida (UP) as well to further expand in handcrafted products as well.

10. Community Development


10.1 Community Water Center

With the aim of providing potable drinking water, a Community Water Center with industrial RO plant was installed in July 2015. Traditional mind sets have slowly crumbled and over 50% people and households utilize the services of the CWC. 20 liters of water is supplied at the doorstep daily. A dedicated team of 2 Social Workers and a Coordinator take care of CWC work. Now villagers are not only availing the services of NGO SAPNA but they are also contributing to meet out the administrative cost incurred in running the Community Water Center. Income so generated is utilized for the salaries of the staff and maintenance of the plant. The total project cost was Rs. 11 lakh and it was funded by Desiccant Rortors Pvt. Ltd under their CSR activity.

Due to some machinery problem, the CWC was non-operational for last six months. We are trying to repair it and start the services again.

10.2 Construction of Individual Toilets

For centuries open defection has been a way of life in the villages. To promote hygiene and to get over the traditional mind set, a project for construction of individual toilets was conceived and implemented in 2015. A major awareness program were launched to enlist the support of the villagers and to make them as stakeholder of the project. Desiccant Rotors International Pvt Ltd and Bry Air (Asia) Pvt Ltd under their CSR program provides financial support for this project.


The cost of each toilet is approximately Rs.45,000. This could vary with changes in the price of raw materials. On an average Rs.10,000 is taken from the households for the construction and the rest has been funded by Desiccant Rotors International Pvt Ltd and Bry Air (Asia) Pvt. Ltd.



It began with construction of seven toilets in village Kaduki. Till the date we have constructed 75 toilets in seven different village such as Chandoli, Thekra, Todiyar, NangliMusnshi, Shahpur. Last year total 15 toilets were constructed and 18 are under construction.

11. Mahila Suraksha Evam Salah Kendra, Alwar

Since December 1, 2008, SAPNA is partnering with local police and Department of Women and Child in Alwar, Rajasthan to run a guidance and protection centre for women known as the Mahila Suraksha Evam Salah Kendra (MSSK). The MSSK is a holistic redressal centre for women providing support to women facing violence by way of:

- assisting them to negotiate their way through the Criminal Justice System;
- settling disputes through alternative dispute resolution mechanisms;
- providing rehabilitation to women survivors of violence;
- providing medical and legal aid, psycho-social support, shelter, economic rehabilitation, and any other relief required

The concept underlying the centre is that of providing a comprehensive strategy of redressal for women who come to the centre for support. The single window assistance can range from mediation to legal aid, to intervention within the police system and the judiciary, to economic rehabilitation, to trauma counselling, to shelter and care.

In last one year, MSSK participated in 23 meetings as an outreach into community and villages. These meetings were organized by other organizations like Ibtada, Sehgal Foundation, Spectra, Savera Mahila Manch, Sangharsh Mahila Manch and with the help of Sarpanch of different villages. Introduction of MSSK and information about 181 i.e Mahila Helpline No. was given in every meeting. Total 938 people were reached out and made aware of MSSK and other VAW laws.



Outreach in Govt School, behind Atta Mandir (Feb 9):

Counsellor Phoolwati and Constable Jyoti visited Government School where they spoke to the children of the school and made them aware about Good Touch and Bad Touch, legislations related to POCSO Act, etc

Counsellor told the children that they shouldn't be going with strangers anywhere. If they feel uncomfortable with the touch then they should run away from there and inform their parents. After the talk, the counsellor had a Question and Answer Session.

Outreach for Saathins (Feb 23) : As part of outreach, Coordinator and Counsellor went to One Stop Crisis Centre in Alwar and informed the ladies about the working of our centre. Coordinator informed them that when women come to our centre, we listen to their plight and, after listening to her, we make her fill the form and then we call the other party against whom the woman has filed the complaint. After calling both the parties a joint meeting is conducted and issues are sorted out. Once the issue is sorted the sahmati patr is filled. During the entire process we ensure that confidentiality is maintained. Coordinator emphasized that the women has to fight for her own rights. As these women are saathins, they can play a crucial role in acquainting others about their rights.

After discussion counsellor gave information about Domestic Violence Act and told Saathins about the clauses of the Act.

Cyber- Crime Workshop – October 15, 2020




Celebrated: - National Girl Child Day Celebration -

Case Study

Neha Choudhary w/o Raj (names changed)

We received a parivaad from 181 and contacted the girl. She picked up our call and spoke to us about her problem in detail. After speaking to the girl the counsellor called her husband and told him about our centre and the complaint which his wife has lodged through 181. He said that he will come on December 2, as he wanted the problem to be sorted out.

On December 2, the parivaadi and her husband came to the centre. Counselor first spoke to her husband. He told the counsellor that he works in some other town while his father works and stays in Agra. Neha stays with my mother in our village. Everything was going fine, and Neha never complained about any problem. He wants to keep Neha. Counsellor then called Neha and asked her to tell about the problem. She told the counsellor that initially everything was going fine but after some time my mother-in-law started misbehaving with me. She started abusing my family. She doesn't want to stay with her mother-in-law. She is ready to stay in Agra. Raj told the counsellor that Neha never discussed the problems, if she must have told him then he would have tried to solve it. Raj said it is not possible for her to stay in Agra but as he has shifted back to his hometown, he will ensure that these problems don't persist. Neha didn't agree so the counsellor gave her time to think.

After 2 days Neha called and she told us that she is ready to go back to her husband's place and she will inform us when she goes. On December 8, we received the call from her father- in-law that they have brought Neha home. Counsellor asked the father-in-law to give phone to Neha. Counsellor spoke to Neha and she said she is fine because her husband is staying with her. She will inform us if any problem reoccur.

12. Sapna Nursery and Environment Development


12.1 Sapna Nursery & Tree Plantation

Gandhi's love for nature and emphasis on "cleanliness as next to Godliness" has been deeply embodied in the work culture of Sapna. The commitment of Sapna to environment protection and cleanliness is of a very high order. In keeping with its deep commitment to environment protection and planting trees and creating gardens Sapna had started its own nursery in 2017 with more than 1000 plants.

The effort is to grow and develop its own plants cost-effectively for its own use and for sale at a very reasonable cost to the villagers of the area. More than 5000 saplings have been planted in the area over the years. Despite the extremities of weather and arid soil, the majority of plants have survived. Sapna Nursery encourages people of the area to plant trees and provides plants at a nominal cost. In 2020 –21 total 1000 plants were planted and 3000 plants were distributed.

12.2 Environment Development

Under its 'Environment Conservation Program' NGO Sapna with the support of villagers undertook the construction of two earthen dam in village Dadikar, Alwar, adjoining Anandam-our old age home. The objective is to trap the rain water coming in from the adjacent hills.

Work on this project started on 18th June 2020. In 15 days both dams were constructed. The size of first dam was 300 ft in length, 60 ft wide and 20 ft in height and second was 550 ft long, 80 ft wide and 20 feet in height.

Three JCBs and 10 tractor trollies toiled round the clock for 15 days and night.

The construction of these two water bodies will have immense benefits in the area. It will not only raise the water table in the entire Dadikar zone and provide drinking water to the livestock and the wild animals but add to the growth of flora and fauna.

The total expenditure entails was Rs. Six lakh fifty thousand. The villagers volunteered to contribute Rs. Three Lakh. The remaining amount of Rs. Three lakh fifty thousand was raised by Sapna.


